THE RIGHTS AND RESPONSIBILITIES OF AUTHORS

Quoting sources. Liability for plagiarism. By submitting an article to Human Rights in Law Enforcement in order to publish it, the author warrants that the document in question includes his own original work and that he has not been previously published or taken into account for publication elsewhere. The author also assures that the ideas and passages within the article that are not his/her own were appropriately attributed, through appropriate bibliographic references and using spelling tools that show the appurtenance of the text or ideas. The author of the article is solely responsible for the failure to comply with the copyright laws and for plagiarism, and **the Human Rights in Law Enforcement Journal can not be held responsible for the authors' failure to comply with the copyright and anti-plagiarism laws.** The editorial staff of **the Human Rights in Law Enforcement Journal** assumes no responsibility for the views expressed by the authors in the published articles.

Respecting the writing requirements of the manuscript. The manuscript sent to the editorial office must comply with the editorial requirements specified on the journal's website in the **Publishing** section.

Not accepting redundant publication. The Human Rights in Law Enforcement Journal does not accept to publish works that have already been partially or fully presented in a published article or are described in another article sent or accepted by other written or electronic publications. If a redundant publication is discovered, the manuscript will be rejected and the published article will be removed from the journal.

Accurate presentation of primary data. The underlying data (statistical indicators, legal regulations, jurisprudential solutions, doctrinal opinions, surveys, etc.) must be accurately presented. The deliberate use of inaccurate or forged data may be a reason for rejecting the manuscript or for withdrawing the published article.

Reproduction and copyright permits/ authorizations. Obtaining reproduction and copyright authorizations for the inclusion or editing of images / works of art or non-copyrighted documents / texts is the responsibility of the authors. The copyright owner will need to be explicitly informed that the artwork / papers / texts will be posted online and can be accessed free of charge as part of the article sent to the editorial board.

Indicating the names of those who contributed to the article. Authors names must be written in the order of their contribution to the article. All authors assume responsibility for their own contributions. The correspondent author (the one who submits the article for publication) must ensure that all co-authors of the article have been mentioned and that all co-authors have seen and agreed to the publication of the material.

Mentioning of financing sources. The financing sources for the research embodied in the article sent for publication (grants, scholarships, etc.) must be mentioned in the paper in a footnote attached to the title of the article.

Prohibition of submitting the manuscript for alternative publication. Manuscripts sent to the editorial board for publication may not be the subject of another offer to other publications except after receipt of the reply, meaning that the material will not be published in the Human Rights in Law Enforcement Journal, or three months after the material was posted to the editorial board and no refusal to publish was received.

Copyright protection of articles published in the Human Rights in Law Enforcement Journal. The author agrees that if it is accepted for publication in the Human Rights in Law Enforcement Journal, copyright will be protected by law under Romanian and European applicable legislation. This means that all the content of the Human Rights in Law Enforcement online version on www.hrle-journal.eu is available free of charge, without charge from the user or his institution.

Users can read, download, copy, distribute, print, search, create links to the text that summarizes the articles in this magazine without requesting permission from the author or publisher, subject to at least the following conditions:

- **state the name of the author (s), the title of the article, the fact that the article is published in the Human Rights in Law Enforcement Magazine and indicate the page (s) cited in the journal;**

- **reproduce the material exactly when it is quoted, used, discussed or multiplied.**

Sending articles via email. Articles to be published will be submitted by the authors only in electronic form to the following e-mail address: submission@hrle-journal.eu

Statement of Liability. Authors whose articles have been selected for publication in the Human Rights in Law Enforcement Journal will need to complete a Declaration of Liability indicating that the article belongs to them, that the sources were correctly quoted, that they did not reproduce the material from unauthorized sources and that the manuscript has not already been published elsewhere.

The discovery of significant errors or inaccuracies in published articles. If an author discovers a material error or inaccuracy in an article published in the Human Rights in Law Enforcement Journal, he or she has to immediately notify the publishers and cooperate with them to correct the article or to withdraw it, as appropriate.

Author's right to receive a copy of the journal. After publishing the article in the Human Rights in Law Enforcement Journal, each author is entitled to receive a copy of the printed magazine, which will be sent to the address indicated by him. Delivery charges by courier will be befalling onto the authors.

STATUS OF THE SCIENTIFIC REVIEWERS

Status of the scientific reviewers. The scientific reviewers of the journal Human Rights in Law Enforcement operate on a voluntary basis. The Editor-in-Chief will send the article for evaluation to at least two referents with scientific competence in the area under investigation, together with an evaluation form. Reviewers who accepted the task of evaluating the manuscript should send the completed evaluation form within two weeks of receiving it. Reviewers have the obligation to refuse the invitation to evaluate a manuscript if the content of the manuscript does not correspond to their fields of expertise or in case of existence of a conflict of interest as defined by Romanian law in the matter.

Confidentiality of information and ideas obtained in the assessment. Insider information or ideas obtained through the evaluation process should remain confidential and not be used to gain personal benefits. Any article received for examination must be treated as a confidential document.

Objectivity of the assessment. When conducting the evaluation, the reviewers are asked to do so as objectively as possible, refraining from engaging in the author's / authors' personal criticism. Reviewers must express their views clearly, explaining and motivating the recommendations made.

Content of the evaluation. Reviewers should submit to the editor's attention any major similarities between the article under evaluation and other articles or published works of which they are aware, as well as any issues that might be related to the ethical acceptability of the described research.

In making the assessment, the scientific reviewers will also take into account the **COPE Ethical Guidelines for Peer Reviewers** published by the **Committee on Publication Ethics**.

THE RIGHTS AND RESPONSIBILITIES OF THE EDITORS

Final decision to publish. The Editor-in-Chief has the ultimate responsibility to decide whether or not an article will be published, taking into account the scientific review, the compliance with the provisions of this Ethics Statement and Copyright Law. The Editor-in-Chief consults with the other members of the Editorial Board, as well as with the scientific reviewers in making the publishing decisions.

Objective evaluation. Prohibition of discrimination on criteria related to the person of the author. Publishers will only evaluate the scientific content of the articles without taking into account the criteria of race, gender, religious beliefs, ethnic origin, citizenship or political orientation of the author.

Estimation of ethical prejudices. When evaluating an article for publication, publishers will be able to request evidence that ethical damage has been minimized in the conduct of research.
